Any speaker that engages in personal attacks and/or acts in an unruly manner will be stopped and may be prohibited from future opportunities to publicly address the Council. The Clerk-Treasurer, Town Council members, Town Attorney and Department Heads are available after the meeting for questions and more extended discussions.
