Brent Lockwood was present to voice his concerns about a sewer issue that he has been dealing with since July 25, 2020, sewer backed up in his home that is only 4 years old. The town was called and the gentlemen that came out was very helpful, the second person had a drawing of the area stating this is where the system is and Lockwood stated that drawing isn't correct, the town employee stated to just change it. Lockwood was told to contact a plumber. A lateral was completed and Lockwood was present during the process. Lockwood was told the town's clay pipes had roots coming through them. It was stated to Lockwood that the ferncove fitting had come apart. Lockwood stated he moved in 10 months after the home was built the town has to inspect the sewer line, the sewer line did not require a bore job. Several calls were made to the utility office and no return call. Someone from the town did stop by one day and pour a gallon of what I believe to be copper sulfate in the sewer system. Once again, I called Luthy office on September 9<sup>th</sup> and was told he would call me back, never heard from him but a gentleman from the sewer department called and said he would be dealing with my concern. Lockwood stated he would like to get answers and clear the matter up otherwise he could contact the office of Indiana Office of Rural Development and IDEM to see their thoughts on the matter. Bettag invoice was paid for by the town of Santa Claus since the blockage was on the town's side of the system.

Russ Luthy stated the drawings are not engineered drawings, they are landmarks, ferncove does not stop the

The town has 65 miles of wastewater lines and the infrastructure is failing, the town has for the last several years bid various rehabs by slip lining of wastewater lines to help with the system. It is very costly. The town has been denied grants based on the income per capita in Santa Claus area.

Michael Johannes asked both Luthy and Lockwood if they would be willing to sit down and meet to discuss the concerns that have been brought up tonight. A date was set for October 16. 2020.

Steve Buse Executive Director of Success Trough Mentoring introduced himself he is the pastor of Bethany Church in Spencer County, a program for kids that have fallen off track. We are looking for funding. The program is in its early stages currently the City of Rockport donated \$6,000.00 and we are hoping Santa Claus will support us as well. Are there any questions?

Michael Johannes thanked Mr. Buse for coming and the council will take a look at this.

## AN ORDINANCE RE-ZONING CERTAIN LANDS IN THE TOWN OF SANTA CLAUS, INDIANA

WHEREAS, Snowflake Village Holdings, LLC, with the consent of Christmas Lake Golf, LLC, has petitioned for the re-zoning of certain lands within the territorial jurisdiction and geographic area of the Town of Santa Claus, Indiana currently within the R-2 and Agricultural Zoning Districts according to the Zone Maps of the Town; and,

**WHEREAS**, on August 24, 2020, the Santa Claus Advisory Plan Commission issued its Resolution 2020-01 certifying said request to the Town Council with a favorable recommendation, following public hearing and due notice according to law.

#### AN ORDINANCE AMENDING ORDINANCE 2019-17

WHEREAS, the Town of Santa Claus adopted its Ordinance 2019-17 establishing salaries for employees and appointed officials of the Town in 2020; and,

WHEREAS, the Town Council has determined that Ordinance 2019-17 requires further alteration and amendment for the salary of the Superintendent of Parks and Recreation.

**NOW, THEREFORE, BE IT ORDAINED** by the Town Council of the Town of Santa Claus, Indiana, that:

Ordinance 2019-17 is hereby amended by adding a new paragraph, as follows:

"The Superintendent shall be paid a commission equal to ten percent (10%) of the rent and/or fees paid to the Town for any and all new activities or uses of the Santa Claus Community Center or Yellig Park which are established during the Superintendent's employment with the Town, except gym memberships and concession sales. Such commission shall be paid quarterly for events occurring and being paid during the preceding quarter, and shall cease upon the termination of the Superintendent's employment with the Town. Such commissions shall be paid from Fund 101950 for Community Center activities or uses, and such commissions shall be paid from Fund 215002 for Yellig Park activities or uses."

**BE IT FURTHER ORDAINED**, that Chapter 1.54 of the Municipal Code of the Town of Santa Claus is hereby amended by deleting the following sentence:

"All receipts for rental of the community center shall be deposited into the Town's Community Center Fund 101950"

and replacing such sentence with the following:

"All receipts for rental of the community center other than gym memberships or fees shall be deposited into the Town's Community Center Fund 101471; and, gym memberships and fees shall be deposited into Fund 101471.010."

**BE IT FURTHER ORDAINED**, that Chapter 1.54 of the Municipal Code of the Town of Santa Claus is hereby amended by deleting the following sentence:

"All receipts for use of Yellig Park shall be deposited into the Town's Parks and Recreation Fund 204002."

and replacing such sentence with the following:

"All receipts for use of Yellig Park shall be deposited into the Town's Parks and Recreation Fund 215471."
