MINUTES

Jason Little made a motion to approve the August 14, 2023 meeting minutes and Patricia Vaal seconded the motion.

COMMENTS FROM THE FLOOR

Bob Duley from the Spencer County Ambulance Service recognized Officer Beau Anderson and presented him with an award for his heroic actions in an accident on 11/25/2022. Officer Anderson was off duty and acted providing a lifesaving tourniquet to a severely injured citizen.

Ryan Griebelbauer representing America Christmas Home Town asked the Council if the town could add the three weekend Christmas event to their liability insurance as was done in the past. Patricia Vaal commented that in the past the America Christmas Home Town would cover any additional expense the town would incur by adding this event. Griebelbauer agreed they could do that. Clerk-Treasurer, Jane Lindsey stated she would contact the Town's insurance agent regarding the additional costs and pass that information on to Griebelbauer. Jason Little made the motion to add the America Christmas Home Town three weekend event to the Town's liability insurance. Patricia Vaal seconded the motion.

Brad Scales from Trailhead SW Indiana presented a plan to bring a mountain bike course to Santa Claus. Scales has been involved in several mountain bike projects in other areas. Scales said he chose Santa Claus as a potential site due to the fact that our high school has a mountain bike club and the town has other bike trails in the community. Kevin Burke said that the Industrial Park would be an option to consider. Patricia Vaal was concerned about the maintenance of the trail system and litter. Vaal asked who would be responsible for these types of ongoing needs. Scales said that there is a team of volunteers along with the kids' clubs that maintain the trails and that would not fall onto the Town. Seth Windell asked how much land would be needed for a project like this. Scales said that any amount of land could be used. Scales they have completed projects of all sizes however to be able to provide a bigger trail systems they would need 50+ acres. Jason Little asked about the estimated costs to build these trails. Scales stated that for pump trails the cost was approx. \$4/foot and for more technical trails it costs between \$3-\$8/foot. The cost would be covered by private grants. Park Director, Zach Tischendorf volunteered to take Scales to a couple of possible sites within the town.

AUGUST REPORTS FROM DEPARTMENT HEADS

Department reports were given to the Council prior to the meeting and are attached.

FIRE DEPARTMENT MAX MEYER

Max Meyer reported they would be doing cooking safety for fire prevention during October 8-14. Medicine Cabinet Clean Out Day would be on October 28th. Meyer also reported that there would not be a Fall chicken dinner fundraiser this year. Meyer asked the ambulance service to bring their Lucas CPR Striker device and give a demonstration on how the device works. The CPR Striker device would provide continuous even compressions for 30 minutes. Meyer wants to purchase this life saving device for the fire department to have on hand in case of community need. The Fire Department would like to purchase the same model as the ambulance service so there is no need to stop and remove our device when the ambulance arrives and both departments will be trained on the same brand and model for continuity of care. Meyer is getting the specs together to start the bidding process and possible bid opening for the next Town Council meeting. Meyer also reported they are looking at old items they might have needed to dispose of and considering a possible surplus auction if the town had enough items.

PARKS & RECREATION/COMMUNITY CENTER ZACH TISCHENDORF

Zach Tischendorf reported that memberships have declined but that is not unusual for this time of the year with school starting back up. Tischendorf also gave an update on increasing the community room rental and decreasing the monthly room rental from \$650/month to \$450/month. Tischendorf presented the timeline of a possible first reading at the November meeting and second at the December meeting with the new prices to take effect the first of January.

BUILDING INSPECTOR TODD HAYS

Todd Hays was absent from the meeting but had asked the Clerk-Treasurer Jane Lindsey to pass on his update regarding the Melchoir house. Lindsey reported that Hays had visited the house in question and that the house remains structurally sound. Per attorney Kevin Patmore at the August meeting that the town's only concern is that the structure of the house meets safety guidelines and per Hays the house meets these requirements. Patricia Vaal reported she had an appraiser reach out to Kevin Patmore regarding the house that the town owns. Patmore reported he has not received the information from the appraiser at this time.

POLICE DEPARTMENT JAMES FAULKENBURG

Police Chief, James Faulkenburg introduced Logan Helming as the new deputy for the town. Faulkenburg said that Helming would be starting the academy in January. The Town Council and Clerk-Treasurer welcomed Helming to the department. Faulkenburg brought up his ongoing concern about the deputies pay being under the current rate of pay in surrounding areas. Faulkenburg reported that the starting pay for our county's officers was \$50,400. Faulkenburg continues to be concerned about losing talented staff to other departments which offer higher pay.

WASTEWATER

Russ Luthy said they were working on a \$3 million project to rehabilitate the current sewer system. Luthy stated that there were 65 miles of gravity sewer lines and they have noted the 6 top offenders that need to be addressed. Luthy said they would be working on 1000-1500 feet per week. Seth Windell asked if this would affect service to customers. Luthy stated that is should not be an issue and that they would send out notices in advance asking the public to lower water usage during the time their area is being serviced.

Kevin Patmore updated the Council regarding the Next Level grant. Patmore reported that the Spencer County Visitor's Bureau committed to contribute \$10,000 to the project if the town receives the Next Level Grant.

CLERK TREASURER JANE LINDSEY

Unfinished Business: 2023 Water and Sewer bank accounts remain unreconciled for the months of Feb.-August. Lindsey has requested the assistance of Suzy Bass who the town has used in the prior year to assist in bank reconciliations.

August Fund Balances: General-\$5,335,191.34 Water-\$2,267,645.20 Wastewater-\$4,793,679.33 TIF-\$750,819.53

Lindsey reported that she would be presenting the 2024 budget for the first reading however Lindsey wanted to point out that the budget was currently over budget by \$26,732.60 due to adding the estimated family insurance amount as requested by the Town Council. Lindsey stated she calculated the family insurance amounts using the estimated rate provided by the agent and budgeting for worst case scenario meaning that all members of each employee's family would be included as instructed by the Council. Lindsey commented that although she recognizes she does not have a vote regarding the budget she recommends that the Council remove the Town Manager from the 2024 budget to bring the proposed budget back into the black. Lindsey stated many facts that supported her opinion with the main focus being on giving the dedicated current employees the extra benefits that they desire instead of budgeting money toward a position that has not been created yet. There was lots of discussion regarding this proposal and many conversations regarding the budget happening at the same time and not all conversations involved the council members. Lindsey brought the meeting back to the basic fact that a decision needed to be made at tonight's meeting to either approve the budget as presented or to do away with the Town Manager for the 2024 budget year and revisit the Town Manager position next year after we see what the final expenses are for the family insurance.

Jason Little made the motion to remove the Town Manager position from the 2024 budget. Seth Windell seconded the motion.

Jane Lindsey presented 2023-12 ORDINANCE 2024 TOWN OF SANTA CLAUS PROPOSED BUDGET for the first public reading. Patricia Vaal made the motion to approve the first reading as read. Jason Little seconded the motion.
