10-10-2023 WATER BOARD MINUTES

The Santa Claus Waterworks Board met in regular session on October 10, 2023 at the Santa Claus Town Hall located at 90 N Holiday Blvd Santa Claus, In 47579.

NEW BUSINESS

Scot Elliott explained that the Patoka Lake invoice for the month of September was incorrect. Chris Glenn has contacted Patoka Lake and adjustments were made. Patoka Lake will be issuing a credit on the October invoice.

Scot Elliott requested the water board meeting be changed to the Tuesday prior to the Town Council meetings. The meeting will continue to be at the Town Hall at 6:00pm. Elliott explained with several projects underway that will require council approval of funds Elliott thought it would serve the water board better if there meeting was prior to the council's meeting each month. Elliott requested the change be made effectively November 2023 with the next water board meeting being November 7, 2023 at 6:00 pm.

Tony Perkins made the motion to change the meeting dates to the Tuesday before the town council meeting effective November 2023. Steve Leibering seconded the motion.

Pay request #12 from Phoenix Fabricators in the amount of \$160,939.50 has been reviewed and approved by Russ Luthy and Midwestern. Frank Fowler made the motion to pay Phoenix Fabricators in the amount of \$160,939.60 as presented. Tony Perkins seconded the motion.

EDA

Elliott reported there was a pre-bid meeting scheduled for October 11, 2023 at 10:00 am. There would be a special meeting held on October 26th at 6:00 pm to open the bids and the project will be awarded at the regular monthly meeting on November 7th at 6:00 pm.

Scot Elliott discussed the Mariah Hill Line project and informed the board they will need to choose an engineering company and the path the line will go.

2024 BUDGET

Scot Elliott reported that the lead testing would not impact the 2024 budget. Chris Glenn explained that all costs would be funded by the 120-water grant. Currently the water department is only working on the inventory part to comply with the first deadline.

Scot Elliott went over the proposed budget line by line and discussion was had by the board. Elliott will make the adjustments noted and update for the November meeting.

Clerk-Treasurer Jane Lindsey

Jane Lindsey presented the estimated family insurance portion that should be included in the water budget for 2024. Lindsey explained that these figures are only an estimated amount and the Council will be receiving quotes from insurance agent Danita Grosvenor soon.

Frank Fowler made a motion to approve the vouchers in the amount of \$194,090.81 and Steve Leibering seconded the motion.
