

**TOWN OF SANTA CLAUS PARK & REC BOARD**  
**Monthly Meeting Minutes**  
**December 5, 2022, 7:00 p.m.**

The December 5<sup>th</sup>, 2022 meeting of the Santa Claus Park & Recreation Board at the Santa Claus Community Center was called to order by President Jonathon Goldsberry at 7:00 P.M.

In attendance were board members Jonathon Goldsberry, Jonathon Kincaid, and Jessi Mullen.

Also in attendance were Zach Tischendorf, Meghan Orgas, and Leigh Ann Wahl.

The board reviewed the November meeting minutes. Jonathon Kincaid motioned to approve the November minutes; Jessi Mullen seconded the motion. Motion carried unanimously.

Zach Tischendorf discussed the progress of the trail project at Yellig Park, mentioning that Quality Craft still needs to complete minor detail work.

Zach Tischendorf and staff discussed the Prancer's Playtime which had 175 visitors. Meghan Orgas and Leigh Ann Wahl mentioned shortening the event from 11 AM – 2 PM but overall they were pleased with event. Zach Tischendorf will discuss with America's Christmas Hometown regarding next year.

Monday, December 4<sup>th</sup> @ 7 PM


Jessi Mullen seconded the motion. Motion carried unanimously.






Jessi Mullen motioned to adjourn, Jonathon Kincaid seconded the motion. Meeting adjourned at 7:50 P.M.
