
Eileen Farmer made a motion to approve the SCCC vouchers in the amount of 2110.34. Jessi Mullen seconded the motion.


Next Park Board meeting is scheduled for December 5, 2022, at 7:00pm at the Santa Claus Community Center.


Eileen Farmer made a motion to adjourn at 8:30pm. Jessi Mullen seconded the motion.
