Eileen Farmer made a motion to approve the SCCC vouchers in the amount of \$8.88. Jessi Mullen seconded the motion.




Next Park Board meeting will be held, Monday February 7th, 2021, at 7:00pm at the Santa Claus Community Center.


Jessi Mullen made a motion to adjourn at 8:45pm. Eileen Farmer seconded the motion.


