

**TOWN OF SANTA CLAUS PARK & REC BOARD**  
**Monthly Meeting Minutes**  
**August 2, 2021, 7:00 p.m.**

The Santa Claus Park Board met for their monthly meeting on August 2, 2021 at the Santa Claus Community Center at 200 N Holiday Blvd, Santa Claus, IN. The meeting was called to order by President Jonathan Goldsberry at 7:00 pm.

Eileen Farmer made a motion to recommend Jessi Mullen to the Town Council for the Park Board vacancy. Craig Buse seconded the motion.

Eileen Farmer made a motion to approve the SCCC vouchers in the amount of \$2796.47. Craig Buse seconded the motion.



Next Park Board meeting will be held, September 8, 2021, at 7:00pm at the Santa Claus Community Center.


Eileen Farmer made a motion to adjourn the meeting at 9:13 pm. Jonathan Goldsberry seconded the motion.


